ASSOCIATE: Any individual of good character who is or has been in, or is employed by, a firm or corporation engaged in a trade, industry or profession related to the building and/or land development industries.

AFFILIATE: Open to anyone who is a co-worker, or employee, of a person who is a builder or associate member.
