Exhibitor Information

All booth deposits must be paid in full and submitted with a signed copy of the Exhibitor Agreement, acknowledging the payment terms listed below. No partial deposits will be accepted. The deposit is required prior to obtaining a booth assignment.

Deposit: Exhibitors who register will be required to pay 1/2 of their balance and subject to the 2nd installment payment terms. Booths are available on a first come first served basis. Ist Installment: Due by January 30, 2020.

2nd Installment: Exhibitors full balance is due by to March 6, 2020. Booths purchased after January 30, 2020 will require payment in full at time of purchase.

A cancellation fee of \$250 will apply to EACH canceled expo booth space.

All fees are non-refundable upon cancellation after 2/15/20.

Booth Inclusions

Indoor exhibitors receives exhibit floor space, standard booth divides (3' low wall and 8' high wall), limited security throughout the facility, general lighting, listing in all published exhibitor lists, electric, 2 exhibitor ID badges, & 2 complimentary expo passes per booth rented.
